We would like to use this opportunity to say to all the Mon PERE children leaving us this summer term, that it was a pleasure having you spend a lovely time with us, and we wish you all the best as you move on to the next stage of your education.



#### **OUTINGS**

From next term we will gradually introduce story time on a boat with the Dudley Canal trust. This activity would last for about 20mins where the children will be accompanied by me on a boat ride singing rhymes and enjoying stories too. This activity will fall on Wednesday mornings but will not be on a weekly basis. As it is on the same day as Rattle and Rhyme, we will split the children into 2 groups and rotate attendance so that every Mon PERE child will get to enjoy both experiences. This will help them develop in all 7areas of learning as we will be learning while on the go.

## ADHOC CARE

From the new term (September 5<sup>th</sup>), ad hoc care will be restricted to weekends and night care only. We would no longer be providing adhoc care services during the week. Only permanent places will be available from Monday-Friday. This is to enable us to have a structured timetable, routine and to ensure continuity of our children's learning and development.

# **FUNDED PLACES**

Parents accessing the EEF funding (15hrs or 30hrs or time for 2's) are now required to pay for their child's meal. Breakfast is £2.00 per day, lunch would be £2.50 per day and dinner will cost £3 per day. This will take effect from September 2022. Payment for meals is to be made weekly in advance.

# **BABY'S DAYS**



Parents/carers should please sign their child's attendance register at the end of each week. It is very important. There is a new option where you can record your child's daily attendance yourself. If you would like to access this option kindly let us know so we can set you up on the system.

Please endeavour to read your child's daily diary and comment on them. We learn a lot about your child from the comments and media that you send to us no matter how little the information or clip is.
